Key Changes for the 2023 Competition

Introduction of a Code of Conduct for entrants and event attendees

Registered Master Builders has introduced a code of conduct for all of our events making it clear to entrants and attendees what our expectations are when entering the competition. Please familiarise yourself with this document.

Region of Entry

From 2023 entries must be entered in the region where they were built. If you want to enter in a region outside of where the entry is built, NMC approval must be sought.

Categories

There are no changes to the categories or other awards for 2023 and we will be continuing with the two New Home Supreme Awards (Over and Under \$1 million) for those regions that qualify.

Entry Fee

There will be a small increase to the entry fee from 2023 as outlined below.

Please note the entry fee is a **contribution** to the cost of the running the competition.

House of the Year provides a wide range of benefits and advantages to those who enter and remains a good investment and good value for our members.

As part of these fee changes, we have also introduced a reduced rate for a first-time entry (since 2015) to help encourage newcomers to the competition.

Other Important Information

Code of Compliance

Code of Compliance is needed by the entries close date. We will accept the final pass notification documentation until the Code Compliance Certificate can be provided. The Code Compliance Certificate must be provided before judging. If it isn't, then the entry will be withdrawn and the entry fee will not be refunded (as judging costs would have been incurred).

Master Build Guarantee

Entries in all categories must have a valid Master Build Guarantee or a waiver taken out and accepted in accordance with the rules of Master Build Services Limited.

If no Guarantee or waiver has been accepted, then a letter from the homeowner confirming they did not want a Guarantee for the property must be provided.

Exceptions to this condition must be approved by Registered Master Builders. No Guarantees will be issued retrospectively.

Note, this does not apply to entries over \$2 million.

Awards

Supreme Award

Please note the following categories are NOT eligible for the Supreme Awards:

- Builder's Own Home
- GIB Show Home

Pink Batts Craftsmanship Award

Entries in the Multi Unit (Apartments/Duplexes/Terrace Housing) category are NOT eligible for the Pink Batts Craftsmanship Award.

Registered Master Builders Supreme House of the Year Over \$1 million



The Registered Master Builders Supreme House of the Year is awarded to up to two of the most outstanding entries in the 2023 New Home categories. For regions with 20 or more entries, two Supreme Awards can be awarded. One for houses under \$1 million and one for houses over \$1 million. **A minimum score of 1850 must be achieved to win a Supreme Award.**

Q&A with Buildcraft

Interview with Hamish O'Carroll

- Q Why do you think the introduction of the "Supreme Home under \$1 million" is important for the competition?
- We all start somewhere and for most it's right there under \$1 million. Acknowledging high quality builds without the big budgets, is not only great for the builders but it's exciting for the everyday homeowner. I think we will see some really great entries going forward and I look forward to being a part of it.
- How did you feel when you won the award, especially considering this is your first year entering?
- We were pretty blown away really to take out the House of the Year National Supreme under \$1 million award! When entering the House of the Year Awards, I thought it would be a great chance to compare the quality of the build and see what we needed to improve on. To then go on and take out a National Supreme Award was a dream come true. The challenge from here is to maintain our high-quality standard of builds.

What do you think made the build stand out from the competition?

- The design and how the house functions on a small section really made it a unique building. This is credit to the impressive thinking of the architects at AHHA Studio. The team did a great job of the gable roof – this aspect took the build to the next level.
- Q What were the key challenges of this build?
- Lockdowns, supply shortages and spiralling costs were definitely a major challenge during this build. Construction wise it was reasonably straight forward and a priority for us was maintaining quality throughout every aspect of the build.
- What does this win do for your company?
- As a young company this win will give potential clients confidence to build with us. The whole competition is also a fantastic opportunity for exposure.

These Awards recognise excellence in building and workmanship and are open to all new homes built within the past two years.

Renovation Awards

These awards are open to all renovations and restorations.

- Renovation up to \$750,000
- Bunnings Renovation \$750,000 \$1.5 million
- Renovation over \$1.5 million

Notes:

- * To enter this category, you must be a member of a Group Builders Franchise Company and/or be building a minimum of 10 houses per calendar year. Each branch/ franchise may enter a maximum of three properties in each category.
- ** To be eligible to enter, properties must:
- Be a minimum of two dwellings that share an inter-tenancy wall, floor or ceiling and be defined by their external walls.
- Be fee simple or unit titled.
- Not be more than 3 levels or 12m high.
- Provide access to a minimum of two units of the same type, or one of each type of unit for judging.
- Entries are defined by their external walls, so a block of units is eligible to enter.
- "Walk-up" properties are also eligible to enter this category (i.e. those properties with no rooms/living areas at ground level).

Builder's Own Home Award



The Builder's Own Home Award is an award for a Registered Master Builder's own home, including new homes and renovations built by the builder. This is not a price-based category.

This is a special category for homes in which any key personnel of any member has a personal interest – his/ her own home. This includes directors, shareholders and spouses including family trusts. Essentially where there could be a conflict of interest.

This category excludes those homes built by the builder for their siblings or extended family members. Sibling or extended family member homes should be entered into the relevant New Home category and must be submitted with a QS report to validate contract price and be built under a fully managed labour contract.

If the home is sold after the close of entry, it will remain in the Builder's Own Home category for the purpose of the competition.

Builder's Own Home is defined as the primary place of residence, holiday home or any property with a personal interest of the key personnel of the member.

Note: Builder's Own Home entries are not eligible for Supreme Awards.

GIB Show Home Award



The GIB Show Home Award is open to show homes and spec homes built by a Registered Master Builder. Show homes and spec homes can be sold and leased back to the entrant but must be open to the public for a minimum of 10 days per month (and for at least two days per week for a period of three months) and may or may not have been lived in at the time of entry.

If the show home or spec home is sold for residential purposes after the close of entry, it will remain in the Show Home category for the purpose of the competition. Please note that if you have built a spec home that does not fit the above criteria, enter it in the applicable New Home category.

Spec homes that do not fit into the GIB Show Home Award (i.e. those that were not built for display purposes and are, or were, not open to the public for a minimum of 10 days per month) can be entered in a New Home category. Spec home entries are only valid if accompanied with a QS report to validate their contract price.

Note: GIB Show Home entries are not eligible for Supreme Awards.

Special Award



The Special Award can be awarded at the regional and national events to an entrant that the judges deem worthy of special recognition for their story or efforts during the build. This is not always awarded.

Pink Batts Craftsmanship Award



The Pink Batts Craftsmanship Award is presented to the entrant who attains the highest score out of the 1300 points available for the workmanship section of the judging criteria. It is awarded for superior attention to detail in all aspects of the build project including structure, cladding, roofing as well as selection, innovation, and suitability of products. It also considers exceptional quality of finish throughout and degree of difficulty of the complete building project.

Lifestyle Awards

In addition to the House of the Year Award categories, there are four Lifestyle Awards categories and a Regional Interior Design Award and the Regional PDL by Schneider Electric Smart Home Award.

All entries in the competition are eligible to win each of these awards regardless of which category they are entered into.

There can only be one winner of each Lifestyle Award per regional event (providing it meets the points threshold), with no other places awarded.

Lifestyle Awards will only be awarded to those entries that achieve 90% or more of the points available for each award (i.e. 450 out of 500).

APL Environmental and Sustainable Excellence Award



This award recognises and rewards new approaches to building and renovating homes. Judges will consider the way the building company has incorporated environmental and sustainable principles in the home's design, choice and installation of materials, and the way in which it has been built.

Below is guidance on some of the environmental and sustainable features the judges will consider.

Environmental

- Sympathy with local environment
- Lifecycle of materials reuse in future developments
- Lifecycle and maintenance in built environment
- Selection of materials carbon footprint manufacture
- Local materials low transport and distribution costs



Design/Dwelling Performance

- Heating efficiency, passive storage, thermal qualities
- Solar technology / power generation

 battery storage, selling to grid, hot
 water, back up
- Operating energy costs
- Stormwater management, water saving, down pipes to storage tanks
- Airflow and ventilation reduce overheating, control of sun and light
- Other systems/products that enhance performance

Product Selection

- Insulation rating, type of glazing and joinery
- Construction materials creating
 thermal mass
- Sustainable/recycled materials

Application and Workmanship

- Quality of application/workmanship
- Appropriate locations of install system

The judges' decision is not limited to the features outlined and the list is subject to change.

Plumbing World Bathroom Excellence Award



The Plumbing World Bathroom Excellence Award will be given to the home with a bathroom that meets the lifestyle and family needs of its owners. Judges look for the bathroom that best demonstrates obvious workmanship quality, specification and installation requirements have been met, and functionality of design and fittings.

"When we won the award we were surprised, elated and excited that all our hard work had paid off. This build is a stand-out due to the detail involved in the home, as well as the unique design."

Note: The sponsorship of the Lifestyle Awards does not imply that only those homes using products associated with the sponsor brand can be recipients of the award.



Kitchen Excellence Award



The Kitchen Excellence Award will be given to the home that meets the lifestyle, family, and entertaining needs of its owners. Judges look for form and function of the kitchen area including design, workmanship, quality of materials, use of light and space, and overall functionality.



Outdoor Living

Excellence Award

The Outdoor Living Excellence Award recognises a Registered Master Builder's commitment to creating a quality home and outdoor living environment that suits the style and personality of the owners. This is awarded to the home that best integrates interior and outdoor living as a seamless expression of the home's design and construction.

Regional Interior Design Award



All regions have a Regional Interior Design Award. All entries are automatically entered into this award.

This award is given to the home which most demonstrates creative use of interior design, colour and finishes and in doing so reflects the living requirements and personality of the owners. Judges look for creative use of wall coverings, colours, materials and fixtures and the overall synergy between the different design elements.

Regional PDL by Schneider Electric Smart Home Award



All regions have a Regional PDL by Schneider Electric Smart Home Award. All entries are automatically entered into this award.

A smart home is a home containing a home automation system. This system is used to control any elements such as lighting, climate, entertainment systems, appliances, heating systems, AV, energy metering and/or security. "I was not expecting to win, so it came as a real surprise! This win puts our company on the map along with a small pool of the country's finest builders who are also National winners. It shows our clients how passionate, committed to superior quality and delivery of an architectural home we are."

How We Judge Your Work

Renovation Awards

Workmanship (1300 points or 65% of the total score). This includes: structure (200 points), external cladding and roofing (350 points), selection, installation, innovation and suitability of products (150 points), finishing (250 points), degree of difficulty (150 points) and general workmanship (200 points).

Retention or creation of character and future proofing (700 points or 35% of score). This includes: creation or retention of character, integration of renovation/ alterations to existing (550 points) and house life cycle (150 points).

The criteria for the renovation award is based on the building consent, and must have a **minimum of 50sqm or 25% of the original walls and floors retained.** If this does not apply, then the property should be entered into a New Home price category.

New Home and Feature Home Awards

Workmanship (1300 points or 65% of the total score). This includes: general workmanship (200 points), degree of difficulty (150 points), finishing (250 points), structure (200 points), external cladding and roofing (350 points), selection of and installation of products made off-site (150 points).

Design, functionality and style (700 points or 35% of the total score). This includes: functionality and design (300 points), fit to site (150 points), marketability (125 points), house life cycle (125 points).

Volume/Group Housing New Home

Workmanship (1300 points or 65% of the total score). This includes: general workmanship (200 points), Degree of Difficulty (150 points), finishing (250 points), structure (200 points), external cladding and roofing (350 points), installation of products made off-site (150 points). Design, functionality and style (500 points or 35% of the total score). This includes: functionality and design (260 points), fit to site/access/entrance (130 points), marketability (60 points), house life cycle (50 points).

General assessment (200 points). This includes construction time frame (100 points) and cost to build/value for money (100 points).

Multi Unit (Apartments/ Duplexes/Terrace Housing)

Workmanship (1100 points or 55% of the total score). This includes: general workmanship (200 points), Degree of Difficulty (100 points), finishing (200 points), structure (150 points), external cladding and roofing (300 points), installation of products made off-site (150 points).

Design, functionality, and style (900 points or 45% of the total score). This includes: functionality and design (350 points), fit to site/access/entrance (200 points), house life cycle (150 points), general considerations (200 points).

Top 100 Finalists


Each year a maximum of 100 residential entries receive Top 100 status. They are determined using the following process: 1. All of the Gold Award results

- throughout the country are pooled. 2. The top three Gold Award winners
- The top three Gold Award winners from each category are automatically selected. Should a category have fewer than three Gold Awards, then only these will go through.
- 3. The remaining places (to make up the Top 100) are given to the remaining highest scoring properties regardless of their category.
- 4. All Top 100 finalists are then rejudged by a new national judging panel to find one winner in each category.
- As per the Terms and Conditions accepted

at the time of entry, all entries are entered on the basis of progressing to the national competition. Entries are not accepted for regional competitions only.

The fee to continue in the national competition is \$650+gst. This entitles you to the following:

- A return airfare to the National Awards in Auckland in November, or we will reimburse you at the appropriate IRD rate (currently 83c/km) with the maximum amount being the equivalent of a return airfare for one person should you choose to drive.
- National finalists will be provided accommodation for the Saturday night, on the basis of one classic room, which includes breakfast for two.
- One complimentary ticket to the awards dinner.

Photography

Photos are used in a range of promotional activities including the House of the Year magazines, website (houseoftheyear. co.nz), display boards, competition collateral, the event showreel, social media, national and regional media as well as by our sponsors. We will arrange photography for all entries and a selection of photos taken will be uploaded onto the House of the Year website. We will send you a copy of the photos following your regional event.

Photography appointments will be arranged directly with the builder and, if possible, will be done at the same time as judging. Both builders and homeowners will be sent a photography guide.

Note: Entrants are welcome to provide their own professional photography, but it does need to meet our photography brief and deadlines. No discount on entry fees is given for those who choose to provide their own photography as our House of the Year photographer will still visit the property to ensure all requirements are met.

Other Requirements

Notice of Practical Completion

Entries **MUST** be complete at the time of entries closing on 24 February 2023 with Notice of Practical Completion being received at that time. The Code Compliance Certificate must also be received when entries close on 24 February 2023. If you are unable to provide the Code Compliance Certificate, we will accept the final pass notification documentation until the Code Compliance Certificate can be provided. This must be provided before judging. If it isn't, then the entry will be withdrawn and the entry fee will not be refunded (as judging costs would have been incurred).

Renovation Entries

All renovation entries **MUST** have before and after floor plans submitted at time of entry.

All renovation entries **MUST** provide before photos if these are available as part of their entry.

Please feel free to share any photographs of the build in progress or even a video time lapse at the time of entry.

Representative at Judging

All entrants must have the person in charge of controlling the site at the time of the build, present at the time of judging.


Your entry could be at a significant disadvantage if your representative cannot answer technical questions put to them by the judges. Should a representative fail to attend the scheduled judging your entry will be withdrawn and the entry fee will not be refunded (as judging costs would have been incurred).

Cancellation Fees

Should an entry be withdrawn, any refund is based on how far along the process the entry is at the time of withdrawal. Any refund will be considered on a case-by-case basis.
